5. Should any customer checks be returned by their bank due to insufficient funds, customer agrees to pay \$15.00 handling fee for each check returned to EMtech Electronics.
6. EMtech Electronics shall not be liable for failure to deliver or delays in goods or services provided occasioned by causes beyond its control, including outbreaks of hostility, acts of God, inability to obtain shipping space, machinery breakdown, delays of carriers or suppliers, and governmental acts or regulations.
7. EMtech Electronics reserves the right at any time to revoke any credit extended to a customer because of customer's failure to pay for goods or services according to credit terms.
